

# Conflict awareness, management and prevention

# Managing sickness absence – identifying and avoiding the pitfalls

Managing staff is not always easy, particularly where there are either persistent or long-term sickness issues. In this session Stephen will alert you to the main problems that arise in this area, and will provide you with pointers on how to address such issues arising from absences in the workplace.

# Evidencing policies and good governance

### Carol Green, Swansea Council for Voluntary Service

Over the last two years, a number of high profile cases of poor governance have hit the headlines. The consequence has been that funders, both charitable and government, have turned their attention to effective governance and the role and active involvement of trustees in ensuring compliance with their own policies and procedures. Audits will now look for evidence of this compliance, as well as financial regularity.

# Getting your accounts right

David will be looking at common weaknesses in accounts, in particular:

- Understanding the different types of fund
- Sensible use of designated funds to send the right messages to users
- Having a reserves policy that is meaningful
- Understanding activity based accounting
- Linking the trustees report with the 'numbers'

He will also give some advance warning on what to expect in SORP 2014.



# Opting to incorporate: looking at CIO and company structures

A year on from the creation of the Charitable Incorporated Organisation (CIO), this session will examine the continuing and growing appeal of incorporation for charitable trusts and unincorporated associations. Martyn will consider some of the lessons that can be learnt from the first wave of CIO registrations, and other incorporation options that are also available to trustees.



### An update on the programme for Welsh language standards investigations

This session will provide an update on the Welsh Language Commissioner's programme for standards investigations. The Commissioner is in the process of collecting evidence from organisations that are required to comply with standards in accordance with the Welsh Language Measure (Wales) 2011. A number of third sector organisations will be part of rounds 2 and 3 of the standards investigation. Come to this session to find out more about the nature of the investigation, which organisations will be under consideration and how the standards will affect you. The Welsh Language Commissioner's officers will also be discussing the Commissioner's wider programme for promoting and facilitating the Welsh language in the third sector.

This workshop will look at how that new Update service can be managed and incorporated into your existing safeguarding procedures, to help ensure safer recruiting when working with vulnerable groups.
